I. Introductory remarks

1. Latvia has been a multinational country throughout its history.

According to the data of the Register of Natural Persons as of 01.01.2023, out of 2,006,794 inhabitants of Latvia with known ethnicity, 1,236,980 (61.6%) were ethnic Latvians.

Persons with the special status of "non-citizen of Latvia", overwhelmingly belonging to national minorities, were 187,404, i.e. almost ¼ of the total number of national minorities. As at 2020, 45% of "non-citizens" residing in Latvia were people born in the country. As at 2012, among people

under 50 years old (40% of all non-citizens), the share of local natives was 74%, but among people under 18 years old (13,374 persons) - 98%¹.

Russian-speaking minority in Latvia makes up 37% of the population (Census 2011) and about 25% of voters (own assessment). The problem of mass statelessness of national minorities has not been solved for 30 years. Non-citizens can't even vote in local elections. Therefore, the possibilities for protecting minority rights by voting in elections are extremely limited for them.

2. After the restoration of independence the population of Latvia is decreasing, and the relative rate of decline of national minorities exceeds the rate of decline of the main nation more than three times (Table 1).

3. In the period from 2019 to the beginning of 2024, Latvia has adopted many legislative and other normative acts that cause discrimination against both non-citizens and citizens of minority origin and, consequently, contribute to the escalation of intolerance in society. This process was particularly intensified when the start of full-scale hostilities in Ukraine on 24 February 2022 was used as a pretext for such rulemaking.

The main directions of this process are discussed below:

- creation of obstacles to the participation of national minorities in public and political life;
- destruction of the education system in minority languages;
- dismantling monuments for fighters of Anti-Hitler coalition and monuments of Russian culture;
- deterioration of the legal situation of permanent residents who have taken Russian citizenship.

II. Creation of obstacles to the participation of national minorities in public and political life

II.1 Restrictions on non-citizens

4. Differences in the rights of Latvian citizens and non-citizens are by no means limited to depriving the latter of the right to vote even in municipal elections. During the period described

above, several more differences were added to the 80 previously recorded by human rights activists².

5. First of all, non-citizens were not allowed to participate in municipal referendums.

Local Referendums Act, adopted on 17 March 2022, which shall enter into force on 1 September 2024, provides for the following restrictions:

- Article 7. (1) The right to initiate a local government referendum shall be vested **in a citizen of Latvia and a citizen of the European Union who is not a citizen of Latvia** but is registered in the Register of Natural Persons [...]
- (2) The right to participate in a municipal referendum shall be vested in a person who, on the date of adoption of the decision on holding a municipal referendum referred to in the second or the sixth paragraph of Article 13 of this Law, meets the requirements of the first paragraph of this Article and is registered in the Register of Voters [...]
- 6. Non-citizens are also not allowed to sign collective petitions addressed to the municipality, which the municipality is obliged to consider.

Local Government Law, adopted 20.10.2022, provides for the following restrictions: Section 56. Collective Submission

- (1) Citizens of the Republic of Latvia who on the date of submitting the submission have attained 16 years of age and whose place of residence has been declared in the administrative territory of the local government or who in this territory own immovable property registered in accordance with the procedures laid down in law are entitled to submit a collective submission to the local government on matters falling within the competence thereof.
- 7. Other additional restrictions for non-citizens include the following.

On April 28, 2022 bill Nr: 1388/Lp13 "Amendments to the Sports Law" was adopted urgently. In the second reading, the proposal was accepted (No. 7, vote: for 50, against 16, abstentions 0), which gives only the citizens of Latvia the exclusive right to be members of the executive institutions of sports federations³.

On June 9, 2022 the Grand Chamber of the ECHR made a negative judgment in case No. 49270/11. The essence of the dispute is discrimination against non-citizens of Latvia when calculating oldage pensions⁴. With this judgment, the court reviewed its own case law⁵.

On September 29, 2022 Parliament adopted the «amendments to Law on the Handling of Weapons». The amendments provide for a ban on non-citizens (as well as citizens of Russia and Belarus with a permanent residence permit) to have hunting, sporting arms, as well as weapons for self-defense (categories B and C).

8. As of 1 July 2020, the Latvian Administrative Violations Code, which provided for an extensive system of fines for violations in the area of the use of the state language, has been abolished⁶. The relevant penalties have been moved to Chapter IV of Law on Administrative Penalties for Offences in the Field of Administration, Public Order, and Use of the Official Language⁷. At the same time, the range of penalties for violations has not decreased, but the size of fines has increased, especially for legal entities.

Besides the raising of fines, the law provides for a general ban to send prospects, newsletters, catalogues and other materials to natural and legal persons in a foreign language along the official language, unless those persons request so (Para. 1 of Section 21).

In this way, public institutions and commercial enterprises are deprived of the possibility to equally respect the preferences of, for example, Russian-speaking customers, as they will be prohibited from sending a bilingual Latvian-Russian catalogue without prior request. The proposal serves no legitimate purpose, as it creates a victimless offence (another similar offence - in relation to certain public information permitted to be disseminated only in Latvian - already exists in the Code, and is retained in paragraph 3 of the same section of the new law).

9. During the coronavirus epidemic (2020-2021), there are problems with informing the Russian-speaking part of the population about measures against the epidemic, including vaccinations. As a result, as of October 2021, 52% of ethnic Latvians and only 42% of persons of other ethnicities had been vaccinated, and among persons 70 years of age and older, 60% and 38% respectively⁸.

In 2022, information in Russian was removed from the websites of all government agencies⁹ and a significant part of private companies, including those directly involved in serving the population.

The amendments to the Labour Law (No. 354/Lp14) were conceptually approved by the Parliament on 14.12.2023 ("for" -72, "against" - 10). The draft law has to pass two more readings in the Parliament.

Amendments stipulate that it will not be possible to unreasonably demand knowledge of the Russian language at any stage of the formation of labour relations. Neither in advertisements, nor during an interview, nor in an employment contract, nor during the performance of work. Unless, of course, this applies to any of the above-mentioned groups of exceptions. The bill provides exemptions for only three groups of professions - academic staff of universities and other

institutions of higher education, librarians, archivists and related professions, and writers, journalists and linguists ¹⁰.

In March 2024, the Ministry of Health submitted to the parliament amendments to the Patient's Rights Law, stipulating the patient's obligation to communicate with the doctor in the state language or to provide an interpreter¹¹.

10. According to the 2021 survey¹², the share of Latvian residents who use certain types of media on a daily basis is as follows: social networks - 61%, internet news portals - 57%, television - 49%, radio - 44%, press publications - 18%. In 2018, these shares were 52, 52, 61, 52 and 16%, respectively.

In general, 65% of respondents (91% of those under 30 years of age) received information predominantly on the Internet, while 32% (76% of those over 65 years of age) received information in traditional media (television, radio, press).

In terms of the language of daily used media, the preferences of consumers were distributed as follows: Latvian - 85%, Russian - 59% (including 94 % of national minorities), English - 35 %. 86% of Latvians and 79% of representatives of national minorities noted the desirability of receiving information in their native language.

11. As of 2021, a significant number of channels retransmitted in Latvia were Russian-made. Russian channels were watched by 59 per cent of national minorities and 35 per cent of Latvians in 2021. At the same time, 78% watched films and serials, 45% watched shows and concerts, 34% watched popular science programmes, and 31% of viewers of Russian channels watched news programmes ¹³.

The top three in terms of popularity until 2022 were almost invariably the First Baltic Channel (PBC), established and registered in Latvia (Baltijas mediju alianse), and through subsidiary companies also in Estonia and Lithuania. The channel rebroadcast Russian public television programmes, but also had original programmes, including a news programme.

There was also a news programme in Russian on the second programme of public television (LTV7).

12. The presence of foreign languages (primarily Russian) in the packages of retransmitted TV programmes was limited by quotas (no more than 35% of airtime) and the need to include in the package several channels produced in Latvia and the EU.

Occasional temporary bans on the broadcasting of some Russian channels due to ideological evaluation of some of their news programmes or formal technical violations were also applied:

- 08.02.2021 the broadcasting of Russia RTR channel in Latvia was terminated for one year 14, and on 24.02.2022 - for another 5 years 15;
- 09.02.2021 broadcasting of NTV Mir Baltic, Ren TV Baltic and several other Russian programmes in Latvia was terminated

In 2020-2022, as described below, the Latvian airwaves were radically cleared of Russianlanguage programmes.

13. On 19 December 2019, the State Security Service initiated criminal proceedings against Baltijas mediju alianse and the firm's founder and co-owner Oleg Solodov for violating EU sanctions against Russia 16. The court of first instance ordered the firm to pay a fine of EUR 3.1 million¹⁷.

On 20.10.2021 PBC's licence was revoked. After the closure of PBC, the popularity of its subsidiary channels PBC Estonia and PBC Lithuania, broadcasting also in Latvia, increased sharply. However, as of 02.03.2023 their licences were also revoked on the basis of negative information about Oleg Solodov from the intelligence services 18. The respective lawsuits were

As of 1 January 2022, the Russian-language part of LTV7 public television broadcasts from the air (including cable retransmission) was transferred to the Internet ¹⁹.

14. In May 2022, amendments to the Electronic Media Law gave the executive branch emergency powers to dismantle television channels "when the country of jurisdiction of an audiovisual programme or audiovisual on-demand service undermines or threatens the territorial integrity, sovereignty or national independence of another country".

On 06.06.2022, 80 Russian programmes, mostly of entertainment and educational nature, including programmes for children, were banned.

Subsequently, two more TV channels for children were banned: "Visiting Fairy Tales" and "I Want to Know Everything"²¹.

In 2022, about 1,000 Internet domains and websites were blocked, where one could, inter alia, watch banned TV channels²².

Finally, the amendments of 10.03.2022 to the Law on Protected Services (Article 7) introduced administrative liability for viewers for viewing prohibited content (fine of up to 700 euros). Ensuring and combating illegal viewing of banned TV channels is particularly characteristic of Latgale, where Russian speakers constitute the majority of the population²³.

II.3 Representation of national minorities in elected authorities

15. Due to the proportional electoral system, parties that rely on the votes of national minorities tend to be well represented in parliament, and for several electoral cycles have formed the largest political group in the parliament. However, in the 30 years since the restoration of independence, they have never been included in the ruling coalition and consequently have not been represented in the government.

National minorities are represented among members of municipal councils disproportionately to their share not only among the population, but even among Latvian citizens who have the right to vote. According to the results of the last elections (2020/21), representatives of national minorities among elected deputies make up 9.9%, candidates - 14.2%, Latvian citizens - 27.6 %; the total population - 37.5%²⁴.

16. In addition to mass statelessness, the disproportionate representation of national minorities among local government deputies is also affected by the language requirements for elected deputies: category C1 (fifth out of 6) for ordinary councillors, and C2 for municipal government heads or their deputies. The procedure for withdrawing the mandate of a deputy who does not fulfil the language requirements has been provided for in the Law on the Status of the Councillor of the Municipal Government Council since the 2013 elections. After the amendments of 13.02.2020, this procedure has become significantly stricter for deputies: the new version of the law provides that councillors who are considered to have insufficient command of Latvian, will have to learn it for their own money. Also, the judicial procedure for removing such councillors from office gets simplified – the judgment of the first instance court will now be final.

17. However, in such places of compact residence of national minorities as the cities of Riga, Daugavpils and Rēzekne, national minority parties have dominated governance: in Riga from 2009 to 2019, in Daugavpils and Rēzekne - currently.

The government is putting pressure on such municipalities.

On 5 April 2019, the long-time mayor of Riga, Nils Ušakovs, was removed from office²⁵, and the Riga City Council itself was dissolved by the Parliament on 13 February 2020. The pretext for the dissolution was non-compliance with rubbish collection procedures²⁶. In the snap elections of 29 August 2020, the parties that rely on the votes of national minorities were defeated²⁷. Since then, the issue of demolishing monuments to anti-fascists and renaming streets associated with Russian cultural figures has been on the Riga City Council's agenda ever since.

The municipalities of Daugavpils and Rēzekne vigorously resisted the government-imposed dismantling of monuments to anti-fascists (see also para 28 below). The authorities openly threatened these municipalities with dissolution and external administration.

On 2 November 2023, the mayor of Rēzekne, Aleksandrs Bartasevics, was removed from office²⁸.

II.4 Restrictions on the activities of political parties

18. On 16.06.2022 the amendments to the law on political parties were adopted. The amendments significantly expanded the capabilities of the special services to oversee the activities of parties, including the initiation of their liquidation.

On April 27, 2022 the Corruption Prevention and Combating Bureau (hereinafter - CPCB) announced the possible termination of funding for political party "Latvian Russian Union" (hereinafter -LRU) from the state budget²⁹. And this publication was not an empty threat. on June 15, 2022 the bank closed the party's account on its own initiative. On July 14, 2022 the CPCB decided to refuse to pay state funding in the amount of 71,904 euros to the LRU. This decision was justified by the fact that the party did not have a current account in any of the registered credit institutions. The account that the party used before is closed³⁰. Accordingly, state funding was interrupted, and just in the pre-election period.

The Central Election Commission in February 2024 twice refused to register the LRU list for the elections to the European Parliament on the pretext that the party did not have a bank account from

which to pay the deposit amount. Therefore, the LRU was forced to nominate candidates from its political alliance partner, the Centre Party, which still has a bank account

19. The issue of the future representation of national minorities in elected authorities is radically resolved in the Pre-election Campaign Law.

On June, 22, 2023 Parliament adopted the amendments to the Pre-election Campaign Law.

According to the amendments, pre-election campaign, the placement expenses of which are included in the expenses to which the restrictions on the amount of pre-election expenses specified by regulatory enactments apply and which are financed from the state budget, shall be performed only in the state language.

Restrictions apply to all types of campaigning - public and private radio and television, printed publications, the Internet and announcements in public places. It should be noted that the phrase "which are financed from the state budget" refers to all political parties that have received the right to subsidies from the state budget, gaining more than 2% of the vote in previous elections.

II.5 Freedom of conscience

20. According to the data of representative surveys the belonging of different ethnic groups to religious confessions can be seen from the following table

While several Western Christian holidays, as Easter and Christmas, are official holidays, not a single Orthodox one is, despite repeated attempts to amend the legislation accordingly³³.

The Latvian Orthodox Church was in canonical connection with the Moscow Patriarchate and, according to Latvian intelligence services, may be an agent of Russian influence among Latvian society³⁴.

21. By amendments dated 06.06.2019 to the Law on the Latvian Orthodox Church it was established that only clergymen of the Church and citizens of Latvia whose permanent place of residence has been Latvia for not less than the last 10 years may be the Primate, metropolitans, archbishops, bishops and candidates for such offices.

06.06.2022 Moscow Patriarchate TV channel "Soyuz" was excluded from the Latvian TV broadcasting grid

By amendments of 09.09.2022 it was established that the Law fully consolidates the autocephalous status of the Church, i.e. the connection of the Church with the Moscow Patriarchate was interrupted.

III. Destruction of education in minority languages

22. ECRI expressed concern about the drastic reduction of the share of mother tongue in school level education programmes based on amendments to the Education law on 22 March, 2018³⁵ (Reform 2018).

In addition to the restrictions described by ECRI, Reform 2018 also provides for significant substitution of the mother tongue with the state language in pre-schools and primary schools (from 1st to 6th grade), as well as halving the hours of mother tongue teaching in schools. Restrictions apply not only to public but also to private educational institutions³⁶.

The reform 2018 affected 73,251 children enrolled in national minority education programmes (as of 2019, 19,207 preschoolers and 54,044 schoolchildren).

Reform 2018 was condemned by the most authoritative international organizations³⁷.

Around 300 individual applications have been registered with the ECtHR concerning various aspects of the 2018 reforms.

In 2023, the ECtHR ruled on three applications concerning public³⁸, and three applications concerning private schools³⁹.

The restrictions were found to be in conformity with the Convention. The applicants on 08.12.2023 and 18.01.2024 filed requests for review of these judgments before the Grand Chamber, which were rejected on 20.02.2024.

Applications relating to restrictions in pre-schools are pending.

UN Human Rights Committee considers Communication no. 4120/2022 filed by 91 parents and their children on 10, February 2020. The Communication addresses all aspects of the 2018 reform and has already gone through all stages of discussion with the Government.

23. On September 29, 2022, the Parliament of Latvia adopted the amendments to the Education Law (Reform 2022, full description see in annex 1), providing for the complete elimination of the education system in the languages of national minorities.

In brief the law provides for the introduction of teaching exclusively in the state (Latvian) language for both preschool and basic school education (up to grade 9 inclusive), and for all types of educational institutions, including private. Pre-schoolers, as well as students of the 1st, 4th, 7th grades will switch to the teaching solely in the Latvian language as from September 01,2023, and the process of switching to the Latvian language for the other grades of the basic school has to be fully completed by September 01, 2025.

24. According to the Reform 2022, for students of national minorities is left the only option to study their native language and cultural-historical subjects outside the school curriculum as part of optional interest-related education programmes. According to the law, the government regulations for conducting and financing these programmes should have been adopted by 31.12.2022. In reality, they were approved only on 28.08.2023, i.e. three days before the start of the school year under the new conditions. Classes are envisaged for no more than three school hours per week, and funding is calculated on the assumption that every fifth pupil will choose the programme.

In a number of educational institutions (especially pre-schools), such interest-related education programmes are completely unavailable or are offered 1-2 times a week⁴⁰. A number of Russian teachers are forced to quit their jobs or are dismissed after tests for knowledge of the state language. 32% of schools have long-term vacancies for teachers⁴¹.

25. During the public discussion of the draft law before its introduction into Parliament out of approximately 4,000 individuals and legal entities participating in the initial discussion of the bill, 97% were against the bill.

In parliament, only MP elected on the list of the Harmony party voted against the bill. All their proposals to mitigate the negative consequences of the bill, for example, not to extend language restrictions to private schools or children with disabilities, to extend the transition period, etc., were rejected.

The 20.06.2022 letter of the OSCE Commissioner for Human Rights sent to parliament, in which he pointed out the non-compliance with the generally accepted OSCE standards of education in minority languages, was not taken into account either.

Also ignored was a collective letter from UN special rapporteurs addressed to parliament the day before the crucial vote⁴².

In February 2024, the Advisory Committee on the Framework Convention for the Protection of National Minorities recognised that the 2022 reform did not comply with Articles 13 and 14 of the Framework Convention and urged Latvia to revise it⁴³.

A consolidated complaints against the 2022 reform for private schools (no. 2022-45-01) and public schools (no. 2023-15-01) is pending before the Constitutional Court and will commence on 19 March and 24 April 2024, respectively.

IV. Dismantling of monuments to fighters against Nazism and monuments of Russian culture (see in details annex 2).

26. On 29 September 2017, the collection of signatures for a petition to demolish the monument to the Liberators of Riga and Latvia from Nazism began. By March 2019, the 10,000 signatures of Latvian citizens needed to submit the petition to Parliament had been collected.

On 26 March 2019, LRU co-chair Tatyana Zhdanok organised the collection of signatures under a petition demanding that parliament draft a law on the protection of monuments and memorials and include a section on the preservation of monuments to the victors of Nazism. Already on 2 April, the petition, under which more than 20,000 signatures had been collected, was submitted to parliament, but was rejected by it⁴⁴.

27. On June 16, 2022, the law «On the prohibition of exhibiting objects glorifying the Soviet and Nazi regimes and their dismantling on the territory of the Republic of Latvia» was adopted by Parliament and on June 22 it came into force⁴⁵ (hereinafter - the Demolition Law). The municipalities in which territory they are located are ordered to dismantle the monuments the title of the law refers before November 15, 2022 (Article 5.5).

Article 4 of the Demolition law names the monument to the Liberators of Riga⁴⁶ by name, and also instructs the government to submit a list of objects subject to mandatory dismantling and the right for municipalities to dismantle other objects as well.

On July 14, 2022, the government regulations No. 448 "List of objects glorifying the Soviet and Nazi regimes to be dismantled on the territory of the Republic of Latvia" were adopted, containing a list of 69 objects to be dismantled.

The list, despite the name of the above-mentioned regulations, includes only monuments of the Soviet era, mainly monuments to the soldiers of the anti-Hitler coalition

28. Attempts to organise peaceful street actions in defence of monuments to anti-fascists were severely blocked by the authorities.

On 30 June 2022, the Daugavpils City Council filed a lawsuit to the Constitutional Court against the Demolition Law (case No. 2022-41-01), on which the Constitutional Court issued a negative decision only on 7 December 2023, i.e. one year after all the monuments had already been demolished.

Five Communications were submitted to the UN Human Rights Committee concerning the monument to the Liberators of Latvia and Riga from the Nazis, as well as other similar monuments in Riga, Daugavpils, Liepaja and Rezekne (Nos. 4203, 4226, 4234, 4235, 4236/2022). In all these cases, between 26 August and 26 October 2022, the Committee issued decisions on interim measures requiring Latvia to suspend the demolition of the monuments pending the outcome of the examination of the Communications. Some of these decisions were received by the Government even before the monuments mentioned in them were dismantled, but none of these decisions were implemented by Latvia.

Communication No. 4203/2022 was submitted by a group of members of the NGO "Latvian Workers' Front", the rest by members of LRU (including elected councillors).

Two participants of Communication No. 4203/2022 (a Lithuanian citizen and a Russian citizen) were expelled from Latvia, and their NGO was liquidated by a court decision on the proposal of the prosecutor's office⁴⁸.

All Communications have already undergone the exchange of views between the petitioners and the Government, as provided for in the Committee's rules of procedure.

29. Local governments have made extensive use of the right granted to them by the Demolition Law (Article 4 (3)), and have demolished about 70 other similar monuments not on the government list⁴⁹.

The demolition of monuments, including those that do not meet the legal criteria, continued beyond the legal deadline (15.11.2022). For example, on 30.05.2023 Riga municipality demolished the monument to Alexander Pushkin, the most revered Russian poet⁵⁰, and on 03.11.2023 the monument to Mstislav Keldysh⁵¹, a native of Riga, president of the USSR Academy of Sciences and head of the Soviet space programme, was demolished.

There is also a widespread campaign to change the names of streets associated with Russian cities, as well as with scientific and cultural figures of Russian ethnic origin, including those who were born or worked in Riga⁵².

V. Deterioration of the legal situation of permanent residents who have taken Russian citizenship

30. On 23.09.2022, i.e. a week before the parliamentary elections, amendments to the Immigration Law were urgently adopted, significantly limiting the rights of citizens of Belarus and especially Russia residing in Latvia.

For these citizens there is a shorter (compared to citizens of other countries) list of grounds for obtaining a residence permit.

The provision that allowed a Latvian citizen and non-citizen who had renounced their former status in favour of foreign citizenship to obtain a permanent residence permit without hindrance was removed from the law.

For those 25,000 persons who have opted for Russian citizenship under this procedure since the entry into force of the current immigration law (01.05.2003), the law has been made retroactive: Paragraph 58 of the transitional rules stipulated that their permanent residence permit remains valid only until 01.09.2023, unless they submit a certificate of knowledge of the state language for category A2 (the second most difficult of the 6) before that date. The certificates issued before 01.01.2001, i.e. in the period when the mass language certification of the Russian-speaking population had already ended⁵³, were not suitable for the procedure under discussion.

Paragraph 58 of the Transitional Rules was challenged in the Constitutional Court (Joint Case No. 2023-04-0106). On 15.02.2024 the court found this legal provision as well as the resulting possibility of deportations to be in conformity with the Constitution⁵⁴.

31. The legal norm establishing language requirements for Russian citizens has been changed twice.

The amendments of 05.04.2023 introduced two additional requirements:

- having a permanent source of income not less than the minimum wage;

- legal residence in the Republic of Latvia for at least five years if absence has not been longer than six consecutive months or it does not exceed 10 months in total.

In addition, a special multi-page questionnaire, including political questions, was required to confirm the residence permit: for example, do you approve of the dismantling of Soviet monuments? The State Security Service (VDD) checked 15643 such forms in 2023 and in 399 cases applicants were refused renewal of their residence permits⁵⁵.

These requirements, including application, also apply to individuals who are exempt from language testing due to age (over 75) or serious chronic illness.

The amendments of 18.09.2023 removed the requirements on the source of income and continuous residence. Persons who came to the language test twice and failed it were offered a residence permit for a period of two years with the obligation to learn the state language during this time.

Many Russian citizens who have fulfilled the legal requirements but have not yet received a new residence permit have their personal code cancelled. As a result, pensions are no longer paid and medical treatment becomes chargeable ⁵⁶.

- 32. During the January (2024) proceedings before the Constitutional Court, the Immigration Service presented the following statistics⁵⁷.
- 25,316 Russian citizens with permanent residence permits obtained under the relaxed formula of the previous formulation of the Immigration Act fell under the amendments of September 2022. As of 1 September, their residence permits became invalid, but some have had their residence permits extended. If they want to stay in Latvia, their goal is to apply for a new EU permanent resident status in Latvia or another residence permit.
- 16,478 Russian citizens have already applied for EU permanent resident status in Latvia.
- 12,029 Russian citizens of those who have applied for the new permanent status have already received it.
- 219 citizens of the Russian Federation from those who have applied for the new permanent status have been refused (they did not fulfil the conditions of stay absence for more than 10 months in 5 years, or minimum income).
- 5132 citizens of the Russian Federation requested a temporary residence permit in Latvia. Including for a temporary residence permit for two years with the rights of permanent residence, which according to the new rules can be obtained by those who took the language exam twice and did not pass.
- 1273 citizens of the Russian Federation have already received a temporary residence permit for two years with permanent residence rights.
- 92 Russian citizens have had their temporary residence permits denied, but they can appeal in court, or make attempts to apply for another residence permit.

About 2,200 Russian citizens did not contact the immigration service and did not submit any documents.

According to the Border Guard Service, about 900 Russian citizens who did not submit any documents have left Latvia. There is no information on the remaining ones.

1167 Russian citizens will receive an exit order by registered letter. In the letter, they will be asked to give explanations for their family circumstances and why they did not fulfil the new norms. По состоянию на февраль 2024 года были выданы первые три распоряжения о выдворении

этих лиц 58 .

Of the 25317 Russian citizens affected by paragraph 58 of the Transitional Rules, 5100 are over 75 years of age, 43 under 15. The remaining are distributed by age as follows. In the group from 15 to 29 years old there are only 232 people. From 30 to 54, the number does not exceed a few hundred, gradually increasing (if Russians from 30 to 34 years of age number 226, then from 50 to 54 years - 650). The number of Russians takes off sharply after 55 years: from 55 to 60 years - 1420 people, from 60 to 64 years - 5346 and from 65 to 69 years - 7329 people. In the group from 70 to 74 years - 3,734 people⁵⁹.

- 33. The heads of the two largest public organisations of Russian citizens with more than 1,000 members each were also expelled from Latvia:
- 10.10.2020 Vladimir Norvind (76 years old at the time of expulsion), Chairman of the Organisation of Russian Military Pensioners⁶⁰;
- 12.01.2024 Boris Katkov (82), Chairman of the Russian-Latvian Cooperation Association. ⁶¹ Both veterans, who had lived in Latvia for several decades, were blacklisted by a decision of the Minister of the Interior and deported immediately without the right to appeal against the deportation decision. Both of them still have families in Latvia.

A total of 8 people were blacklisted in 2023 at the initiative of the State Security Service⁶².

VI. Incitement to hatred

VI.1 Sympathies for the Nazi past

34. Such manifestations of sympathy for the Nazi past as the demolition of monuments to antifascists and marches in honour of the Waffen SS legion have recently been condemned by the UN

General Assembly 63 , and the annual marches on 16 March in Riga have also been condemned by the ECRI 64 and the European Parliament 65 .

Nevertheless, traditional marches of Latvian SS Legion supporters on 16 March were held in Riga in 2019⁶⁶, 2022⁶⁷, 2023⁶⁸ and 2024⁶⁹.

In all these cases, the approval of the march met with no obstacles from the municipality.

On the contrary, parallel anti-fascist events were subject to unreasonable restrictions, and the events usually took the form of "spontaneous pickets", which by law do not require authorisation. For example, on 16 March 2023, Jelgava Councilor form LRU Andrejs Pagors was detained by the police after he came out with an anti-fascist poster in the square near the Freedom Monument. The court subsequently cancelled the fine imposed on the Pagor⁷⁰.

In 2020⁷¹ and 2021⁷², marches were not held due to the coronavirus epidemic.

35. Sympathy for the Nazi past is demonstrated by influential forces represented in the parliament and government.

On 25 February 2019, the National Alliance, part of the ruling coalition, introduced a bill in the ruling coalition to declare 16 March as an officially observed day of the ⁷³.

In September 2019, Defence Minister Atis Pabriks, speaking at an event dedicated to one of the battles of the SS Legion called the Legionnaires the pride of the Latvian people and the state⁷⁴.

In February 2020, a film "Latviešu leģions Taisnības augšāmcelšanās" [Latvian Legion Resurrection of Righteousness], clearly glorifying the events of Nazi past, was made with the support of the Deputy Chairman of the Parliament's Education and Culture Commission Rāvis Dzintars. The film would have been sent to 400 schools with the aim of incorporating its viewing into the curriculum⁷⁵.

LRU co-chair Tatyana Zhdanok's complaint about this film to the State Security Service was left without satisfaction ⁷⁶.

VI.2 Supporting collective manifestations of hatred

36. An application for the march on May 28 2022 with an estimated number of participants of 100 people was submitted by LRU co-chairman Miroslavs Mitrofanovs on May 16. A much larger event, announced for May 20 - the procession from the Monument of Freedom to

A much larger event, announced for May 20 - the procession from the Monument of Freedom to the Monument of Liberators of Riga and Latvia from the Nazi invaders - the Riga City Council was not going to object 77. It was supposed by blocking traffic on the bridge across the Daugava River on Friday during a rush hour, while the residents of Riga leave for their summer cottages 78. Apparently, the authorities of Riga supported the slogans of the procession: destruction of all monuments of the Soviet era, deportation from Latvia of all those who do not agree with this, as well as the deprivation of citizenship for these persons, lustration and restrictions on the right to participate in elections 79. About 5,000 people participated in the procession, according to police 80. Miroslavs Mitrofanov's application for a procession along the same route, but in the exact opposite direction and with exactly the opposite slogans, scheduled for a day off, crossing the bridge along the sidewalks, was rejected.

37. The collective petition "Prohibit pro-Kremlin persons from holding positions in state and municipal institutions" submitted by the initiators of the march described above was supported by

the parliament⁸¹. By amendments dated 21.12.2023, the State Administration Structure Law introduced the concept of loyalty for all state and municipal employees.

38. Numerous hate speeches by social activist and New Conservative Party member Liana Lange have led the party to nominate her as the leader of its electoral list for the European Parliament elections⁸².

She launched the campaign "Atkrievisko Latviju!" ("Derussify Latvia!"). Lange calls on her supporters to rid Latvia of any trace of the Russian language, calling local Russian speakers "occupiers and colonists". For example: «Diemžēl ne Vācijas, ne ASV Riga vēstniecība krievu valodu no tīmekļvietnes nav izņēmušas.» [Unfortunately, neither the German nor the US have removed Russian from the website."]⁸³

"Kā tas nākas, @_vvc , ka Latvijā valstsnācija tiek terorizēta publiskajā telpā ar bijušo okupantu un kolonistu - krievu valodu? Kāpēc mums savā valstī jāpiecieš divvalodība un krievu lingvistiskā agresija? KO? Kāpēc jūs publiski nekomunicējat, ja jums ir "X" konts?"["How is it, @_vvc , that the Latvian State Nation is being terrorised in public space by the language of the former occupiers and colonists - Russian? Why do we have to tolerate bilingualism and Russian linguistic aggression in our country? WHAT? Why don't you communicate in public if you have "X" account?"] ⁸⁴ In this regard, a group of opposition politicians submit an application to the law enforcement authorities with a request to assess Langa's statements and activities in public space from the position of "inciting national hatred" ⁸⁵ .

Lange was called to the State Security Service for explanations, but no other action was taken against her⁸⁶.

Moreover, after these events, President Egils Levits awarded Lange the award "For promoting Latvia as a national state and the Latvian language as a public language of communication, for the struggle against expressions of the consequences of the colonialism of Soviet and Tsarist Russia and for civic courage and activism" ⁸⁷.

VI.3 Examples of hate speech by public figures - journalists and politicians

39. Journalist Armands Puče in his article "Šobrīd 20 % no visiem Latvijas skolēniem nemācās latviešu skolās. Latvija par to maksā" [Currently, 20 per cent of all Latvian schoolchildren do not

study in Latvian schools. Latvia is paying for this] ⁸⁸ repeatedly compared Latvian national minorities (primarily Russians and Russian speakers) to pigs.

For example: «Vai tad nav redzams, vai tad nav pārbaudīts, ka visa šī ņemšanās ap "krievu skolām" ir nekas vairāk kā cūku barošana?» [Is it not obvious, has it not been verified, that all this fuss about "Russian schools" is nothing more than pig-feeding?], as well as making veiled threats on ethnic grounds -«Nevienai cūkai pirms nokaušanas neprasa, vai viņai vajadzīgs pārejas laiks, lai sagatavotu sevi cepetim...» [No pig is asked whether it needs a transition period before slaughter to prepare itself for the roast].

After numerous complaints and requests for legal assessment of the statements were submitted to law enforcement authorities, the Ministry of the Interior issued an opinion stating that "freedom of speech implies the right of journalists to provocative materials on topical issues". The State Security Service also found no offence in his statements⁸⁹.

40. Janis Reirs, a member of parliament from the premier's New Unity party, called his Russian-speaking parliamentary colleague Viktorija Pleskane a "Russian scavenger" in front of a large crowd of people⁹⁰. Pleskane followed up with an application to the parliamentary ethics commission, but the commission refused to initiate disciplinary proceedings, verbally urging Reirs to be more careful in his statements from now on⁹¹.

VI.4 Individual Hate Speech

41. Hate speech was monitored by the Latvian Centre for Human Rights from January 2021 to November 2023 in the most popular social networks and in the comment sections of news websites. A total of 2,414 cases of hate speech were identified, of which 1,607 on social media and 807 on news portals.

Most often ethnic hatred was recorded against Jews - in 44.9 per cent of cases. It is followed by hate speech against Russians (30.7 per cent), Ukrainians (13.4 per cent) and Latvians (6.2 per cent). In 45 per cent of cases, hate speech was identified as homophobic, 20 per cent were ethnically based, 18 per cent were xenophobic, 6 per cent were racist, and 5 per cent were transphobic ⁹².

VII. Criminal prosecutions of dissenters

42. The State Security Service (VDD) has initiated numerous criminal cases against national minority activists whose guilt, in our view, consists solely of public opposition to the state policy described above.

In total, for all reasons, the State Security Service started or took over from other institutions 64 criminal proceedings in 2022 and 47 in 2023. There were 26 and 27 such processes in 2019 and 2020, respectively⁹³.

The use of measures such as searches, detention, confiscation of office equipment, restriction of access to bank accounts, pre-trial detention and/or various police restrictions during the investigation period are in themselves a sensitive means of punishing and intimidating those who share the views of these victims of arbitrariness.

Examples below are Vladimirs Lindermans, Jurijs Aleksejevs, Aleksandrs Gapoņenko and Tatjana Andrijeca, mentioned by the security service (and others not mentioned) in the context that the criminal proceedings initiated against them drastically reduced the intensity of their social activities ⁹⁴.

43. Vladimirs Lindermans, a Russian-speaking opposition publicist, was detained by the VDD on June 21, 2022⁹⁵. The court ordered his arrest as remand custody. His lawyer, Jelena Kvjatkovska, stated that Vladimirs Lindermans is a suspect of committing a crime under article 74.1 of the Criminal Code in the part which refers to the crime against peace.

Vladimirs Lindermans stays in custody after the arrest and the custody was prolonged on August 23, 2022 for another two months after the VDD investigator declared they also suspected Lindermans of committing a crime of inciting hatred towards ethnic Latvians which is envisaged by Article 78 of the Criminal Code.

In autumn 2022 Lindermans was released on €6,000 bail and in February his case went to trial ⁹⁶. On 23 May 2023, the first hearing in his case took place ⁹⁷ and the trial is still ongoing. Vladimirs Lindermans is a non-citizen of Latvia.

44. This is not the first time that Vladimirs Lindermans has been harassed by the VDD for his views. In 2018, he was brutally detained by VDD officers, who threw him to the ground and dragged him to a minibus without police stenciling 98. He was charged with three criminal articles: "activities against the Latvian state", "incitement of national hatred" and "organisation of mass riots". Linderman then exercised his right to obtain compensation for the material and moral damage caused during the trial, and the State Security Service immediately reopened the

investigation into the previously closed case on the decision of the prosecutor of the General Prosecutor's Office⁹⁹. However, the case was eventually permanently dismissed in 2021¹⁰⁰.

45. In February 2020, the trial of Aleksandrs Gaponenko started. He was accused of committing an offence under Article 78(2) of the Latvian Criminal Law - incitement of enmity or hatred on grounds of racial, ethnic and national affiliation, including on the Internet. According to the indictment, the incriminated acts manifested themselves mainly as publications on the Internet. In December 2020, the court sentenced him to a one-year suspended sentence followed by two years of probation supervision¹⁰¹. The defendant and his lawyer did not agree with the verdict and appealed it to a higher court.

In 2022, the court sentenced Gaponenko to one and a half years of suspended imprisonment in another case. He was found guilty under three articles of the Criminal Law - for inciting ethnic hatred, actions against the state and assisting a foreign state in actions against Latvia. In addition to a suspended sentence, Gaponenko was also given a two-year probation period and one year of probation supervision. According to the defence lawyer, the court verdict will be appealed against ¹⁰².

46. In February 2023, Tatjana Andrieca, a 22-year-old Saint Petersburg university student, was arrested. This Latvian citizen was arrested in Riga, where she had come to visit her mother during the winter holidays.

After eight months in prison, she was released on her own recognizance on 4 October 2022 ¹⁰³. Her case is currently in the prosecutor's office and has not yet been brought to court. Tatjana Andrieca is charged under the second part of Article 89.1 of the Latvian Criminal Law for leading a criminal organisation or participating in crimes committed by such an organisation. This article prescribes a penalty of life imprisonment or imprisonment for a term of 10 to 20 years with or without confiscation of property and a probationary period of up to three years.

47. In April 2023, court hearings began against 14 Latvian journalists who cooperated with the Rossiya Segodnya MIA holding company¹⁰⁴. Pressure on journalists has been going on since December 2020, when VDD representatives came to some of them (seven), searched them and seized documents linking them to the Rossiya Segodnya news agency, data carriers (computers, mobile phones, flash drives) and bank cards. The data carriers were later returned to them. After a year, they were removed from their non-suspension signatures and the seizure of bank accounts was cancelled.

In the winter of 2022, the prosecutor's office completed the pre-trial investigation of the case, divided it into 14 separate cases and brought it to trial. At the moment, the trials are still ongoing

and the prosecutor's office is charging the journalists under Article 84 of the Criminal Law of the Republic of Latvia for violating the sanctions regime, considering that the Rossiya Segodnya news agency is subject to sanctions imposed personally on the agency's general director Dmitry Kiselyov in 2014, although the news agency itself was not sanctioned by the EU until December 2022. The article prescribes a penalty of a fine or community service or short-term imprisonment followed by probation supervision or imprisonment for up to four years.

48. The case of Jurijs Aleksejevs, former editor-in-chief of the Business Baltija newspaper and creator of one of the most popular discussion portals in Latvia, turned out to be the most advanced. In January 2023, in one of the two ongoing criminal cases against him, the court of appeal sentenced him to a year and a month in prison¹⁰⁵. Jurijs Aleksejevs appealed this decision to the Supreme Court¹⁰⁶.

Also in April 2023, another trial began, where Jurijs Aleksejevs is accused of acting against Latvia's sovereignty ¹⁰⁷. He could face up to eight years in prison under this article.

Jurijs Aleksejevs, since the criminal proceedings against him were initiated in December 2017, has been on a recognised recognisance for two years, as well as under police supervision, being obliged to stay at home at night and to go to the police station three times a week to check in.

49. Alexander Dubiago, aged 22, was arrested for unfolding the official banner of Russia in the square of the Monument to Liberators of Riga on May 10, 2022. He also spoke up calling to revere the memory of the ancestors who perished in the WWII¹⁰⁸. Alexander Dubiago is charged with violating article 74.1 of the Criminal Code of Latvia. On June 17, 2022 it became known that the court ruled Dubiago's release on bail. On 30 December, according to the State Security Service, the criminal proceedings were terminated on the basis of instructions from the supervising prosecutor and senior prosecutor that no criminal act had been committed ¹⁰⁹.

50. In January 2023, Marat Kasem, a Latvian citizen and editor of the Russian portal Sputnik in Lithuania, was arrested. He came from Moscow to Riga to say goodbye to his dying grandmother. On 30 December 2022, Kasem was detained in Latvia on suspicion of espionage and violation of European Union economic sanctions. The prosecutor's office charged Kasem under the Criminal Code article for aiding and abetting a foreign State in an act against the Republic of Latvia. In July 2023, according to the judgement of the General Prosecutor's Office, Kasem was found guilty and convicted of aiding and abetting a foreign state in an act against Latvia. Kasem made a plea bargain with the investigation, pleaded guilty and received a fine of 15,500 euros 110.

51. In 2018, the VDD opened a criminal case on possible offences during the All-Latvian Parents' Meeting. The case involved several people, including the leader of the Russian Union of Latvia party, MEP Tatjana Zdanoka, Vladimirs Lindermans, Aleksandrs Gaponenko and Ilja Kozirevs, as well as two mothers of schoolchildren.

They were suspected of inciting ethnic hatred for criticising Latvia for converting school education to Latvian. In 2020, the criminal case was dropped by the VDD for lack of corpus delicti¹¹¹. Also in 2020, the VDD closed the case against Zdanoka, who was suspected of inciting ethnic hatred¹¹².

52. B In April 2023, the VDD detained a civil activist Aleksandrs Žguns is charged under of Article 89. 1 of the Latvian Criminal Code for leading a criminal organisation or participating in crimes committed by such an organisation. As evidence in the criminal case are his comments and photos published by him on a Russian Telegram channel. After 4 months in prison, he was released on 11 August 2022 on bail of 6,000 euros collected by the public and on his own recognisance. His case is now in the prosecutor's office and has not yet been brought to court. This article provides for a penalty of life imprisonment, or imprisonment for a term of 10 to 20 years with or without confiscation of property, and with a probationary period of up to three years.

The complete destruction of the education system in the languages of national minorities in Latvia is provided for by law in the nearest future

Protests, pending submissions to the ECtHR and the UN Human Rights Committee as well as officially expressed negative opinions of international organisations on previous reforms related to the partial transfer of national minority programs to the state language of instruction, did not prevent the adoption of the new legislative framework, which leads to the complete elimination of the education on the languages of national minorities in Latvia.

1. Latvia is a multinational country where education in the family language for ethnic Latvians and the Russian-speaking minority was provided for the entire period since the First Latvian Republic was created in 1918. After the restoration of independence in 1991, two equivalent education systems existed in parallel in Latvia - in Latvian and Russian languages with in-depth study of the second language (respectively, Russian or Latvian) as a separate subject.

According to the 2011 census, for 62.1% of the residents, the family language was Latvian, and for the remaining 37.9% - minority languages, including for 37.2% - Russian.

Share of representatives of ethnic minorities in the age group (7-18) in 2011 was 27,2% (ethnic Russians – 20%), and the share of schoolchildren enrolled in national minority programs – 27.6% (in Russian – 26,8%). This proportion has not been substantially changed throughout the entire period after 1991, which proves the demand for maintaining education in minority languages 1 . According to the data of 2021, 16,059 children (16.1%) studied in preschool institutions in languages other than Latvian, and 45,675 3 (22.7%) in general education schools (already after the transition to the Latvian language of instruction in secondary school).

2. Over the past 30 years, the obvious direction of the "educational reform" of national minority schools has been the increasing replacement of the native language of instruction with the Latvian language⁴.

As a result, the objective comparative indicators of the competitiveness of graduates of national minority schools deteriorated significantly⁵, and the observed improvement in their knowledge of the Latvian language did not correlate in any way with the proportion of the introduction of this language as the language of instruction⁶.

All stages of the "reform" took place without the consent of the national minorities but, on contrary, with their active resistance⁷. All surveys conducted among representatives of national minorities indicate a clear support by the vast majority of them for the preservation of education in their native language⁸.

3. The latest of the previous reforms which took place in 2018⁹ led to the complete elimination of education in Russian in private universities and colleges, as well as in secondary public and private educational institutions.

In pre-school institutions (from the age of 5) and in basic schools, Latvian has become the dominant language of instruction (at least 80% of teaching hours in grades 7 to 9, and at least 50% in grades 1 to 6th).

These legislative changes received a huge criticism of all major international organisations ¹⁰. Several hundreds of grounded complaints of parents of preschool- and schoolchildren have been registered by the European Court of Human Rights ¹¹ and the UN Human Rights Committee ¹². Nevertheless, ignoring all international recommendations, not even waiting for the previous stage of the "educational reform" to finish and evaluating the outcome of the relevant litigation, the ruling coalition on February 28, 2022 took a conceptual decision on the definitive transition of the

entire minority education system (including the preschool education) exclusively into the Latvian language of instruction¹³.

On September 29, 2022, the Parliament of Latvia adopted the amendments to the Education Law (Annex 1, hereinafter referred to as the Law of September 29, 2022), which came into force on October 25, providing for the complete elimination of the education system in the languages of national minorities.

4. The law of 29.09.2022 provides for the introduction of teaching exclusively in the state (Latvian) language for both preschool and basic school education (up to grade 9 inclusive), and for all types of educational institutions, including private. Pre-schoolers, as well as students of the 1st, 4th, 7th grades will switch to be taught in the Latvian language only from 01.09.2023, and the process of switching to the Latvian language in the rest of the basic school grades is to be fully completed by 01.09.2025.

Students of national minorities are left with the option to study their native language and cultural - historical subjects outside the school curriculum as part of optional interest-related education programmes. The issues of financing and organisation of this process will be established by government regulations to be adopted before 31.12.2022. As of mid-December 2022, drafts of these regulations have not been published.

The Law of 29.09.2022 also provides for exempting educational institutions from teachers to whom the Latvian language is not native - based on the results of testing their knowledge of the Latvian language. The audit process, which provides for the immediate removal of teachers from work, followed by further dismissal if they do not pass the re-test their highest level of proficiency within 3 months, began from the moment the law entered into force.

5. The basis for the adoption of the Law of September 29, 2022, as explained in its annotation ¹⁴, is the insufficient knowledge of the language of some of the graduates of national minority schools: it was concluded that almost 39% of young people belonging to minorities, according to their self-assessment, know the Latvian language excellently, the same number of young people know the Latvian language well. However, 20% admitted that they have learned the Latvian language at the basic level or know it poorly. The annotation states that in order to promote the integration of society on the basis of the national language, the proficiency of the official language must be at a very high level, close to the proficiency of the mother tongue¹⁵.

The formal goal of the law is to overcome segregation and create a unified education system. In fact, the separate education system for Latvians and students belonging to national minorities, which is to be destroyed, satisfies all the criteria for the admissibility of separate education ¹⁶. On the contrary, the use of uniform educational programs in Latvian for schools where children

from each of the two major language groups study separately is a classic example of segregation.

6. While implementing the decision of the ruling coalition of 28.02.2022 (see §3 above), the Ministry of Education and Science has developed the relevant bill (22-TA-1134)¹⁷ and on 08.04.2022 submitted it for public discussion, which lasted until 22.04.2022¹⁸. At this stage of public discussion proposals were received from almost 4,000 individuals and legal entities, with 97% of participants opposed to the bill. The 3% supporting the bill did not represent national minorities. In particular, two legal entities and 974 individuals supported the following recommendation of the Latvian Human Rights Committee: to withdraw of the bill from consideration before decisions on complaints concerning the previous stage of school reform will be taken: case No. 56928/19 in European Court of Human Rights and case No. 4120/2022 in the UN Human Rights Committee.

During the discussion of the bill in the Parliament, all proposals of MPs representing national minorities were rejected, including the compromise ones as, for example, not extending new language restrictions to private educational institutions or programs intended for children with special needs, as well as on the undertaking of measures to eliminate segregation that has developed as a result of the adoption of the law (see §5 above).

The negative opinion of the OSCE High Commissioner on National Minorities concerning the bill sent to Parliament on June 20, 2022 was not taken into account by the ruling majority as well.

- 7. On October 28, 2022, 20 opposition MPs contested the Law of 29.09.2022 in the Constitutional Court¹⁹. The decision to initiate a case or to refuse to initiate a case, the court will take until January 2, 2023. In any case, such lawsuit cannot stop the dismantling of the education system for national minorities, which began with the mass dismissal of teachers capable of teaching the relevant programs. In addition, the legal process, which, according to the law, lasts for about a year, simply will not be completed by 01.09.2023, the date when all pre-school and part of the basic school education will be conducted exclusively in Latvian.
- 8. Unfortunately, all domestic measures to encourage the government of Latvia to comply with international norms concerning the protection of the rights of national minorities were ineffective. Therefore, the appropriate legal pressure on Latvia by those international institutions that have been created to ensure the implementation of these norms is urgently needed.

Amendments²⁰ to the Education Law²¹ (entered into force 25.10.2022)

(unofficial) Translation of the text into English including the consolidated version of the sections amended, and comments on the content of the amendments.

[Extracts from the current law are presented in italic type]

I. Amendments as adopted

1. Delete Section 9, Paragraph 2, Clause 2.

Section 9. Language in which Education is Acquired

(2) Education may be acquired in another language:

2) in educational institutions which are implementing minority educational programmes on the level of pre-school education and basic education in conformity with the provisions of Section 41 of this Law;

2. Supplement Section 14 with Paragraphs 47 and 48 in the following wording: Section 14. Competence of the Cabinet in the Field of Education

The Cabinet shall:

- 47) determine the model of the interest-related education programmes for the study of the minority language and the cultural history and the guidelines for its implementation;
- 48) determine the criteria and procedures by which the State participates in the financing of remuneration and acquisition of teaching aids for teachers involved in implementation of the interest-related education programmes for the study of the minority language and the cultural history.

3. Section 30:

supplement Section with Paragraph 4.² in the following wording:

Section 30. Head of an Educational Institution

- (4) A person who has impeccable reputation, who is loyal to the Republic of Latvia and its Constitution, inter alia, does not violate the prohibition of discrimination and differential treatment towards a person, who has the relevant education and the necessary professional qualification is entitled to work as the head of the educational institution. A person who has a higher pedagogical education or a higher and pedagogical education, and also a person who has a higher education and is acquiring a pedagogical education is entitled to work as the head of a general basic or general secondary education institution.
- (4^{l}) The professional activity of the heads of educational institutions (except for higher education institutions and colleges) shall be evaluated by the State Education Quality Service in accordance with the procedures stipulated by the Cabinet at least once in six years. The head of an educational institution who has taken the office shall be evaluated for the first time within two years, but not sooner than six months after taking the office. The suitability of the head of the

educational institution for the position to be held shall be decided based on the assessment results. If the professional activity of the head of the educational institution has been assessed as unsatisfactory, the person is prohibited from holding the position of the head of the educational institution. The assessment results may be taken into account upon determining bonuses and gratuities for the head of the educational institution.

(4²) A person who knows and uses the official language to the extent necessary to perform professional and official duties provided for by regulatory enactments, except for other cases provided for by law is entitled to work as the head of the educational institution.";

Supplement Section with Paragraphs 7 and 8 in the following wording:

- "(7) If the State Language Centre has established that the knowledge of the official language of the head of the educational institution does not correspond to the level of official language proficiency determined by the Cabinet of Ministers, which is necessary for the performance of his professional and official duties, an entry is immediately made into the Register of Teachers. The employer of the head of the educational institution shall ensure that the relevant head of the educational institution is suspended from the performance of his duties until the day he passes the official language proficiency exam to the extent necessary for the performance of professional and official duties. If, within three months, the head of the educational institution has not passed the examination on knowledge of the official language to the extent necessary for the performance of professional and official duties, the employment legal relationship with him shall be terminated. An appeal against a decision taken by the State Language Centre shall not suspend its operation.
- (8) The entry in the Register of Teachers referred to in Paragraph 7 of this Section is immediately deleted if the finding of the State Language Centre regarding an insufficient level of proficiency in the official language is cancelled or information on the passing of the official language proficiency exam of the head of the relevant educational institution is updated in the State Examinations Information System to the extent necessary for the performance of professional and official duties."

4. Express Paragraph 1 of Section 35.¹ in the following wording:

Section 35. State Examination Information System

- (1) The State Examination Information System is a State information system in which information regarding State examinations in general education programmes, including information regarding examinations of an international testing authority in a foreign language, information regarding State examinations in vocational education programmes, except for the first and second level vocational higher education programmes, and also information on examinations of the proficiency in the official language is entered.
- (1) The State Examination Information System is a state information system that records information about the following state examinations:
- 1) for State examinations in general education programmes;
- 2) for State examinations in professional education programmes, except for higher education programmes;

- 3) for diagnostic (monitoring) works;
- 4) Olympiads of study subjects;
- 5) official language proficiency examinations;
- 6) international testing institution for examinations in a foreign language."

5. Delete Section 38, Paragraph 2, Clause 1.

Section 38. Types of Educational Programmes

- (2) The specific types of educational programmes shall be as follows:
- 1) educational programmes for ethnic minorities;

6. Delete Section 41.

Section 41. Educational Programmes for Ethnic Minorities

- (1) Educational programmes for ethnic minorities shall be developed by an educational institution selecting any of the model educational programmes included in the guidelines for the State preschool education or State basic education standard.
- (1^{+}) From grades 1 to 6 in educational programmes for ethnic minorities, the acquisition of learning content in the official language shall be ensured in the amount of not less than 50 per cent of the total lesson load in an academic year, including foreign languages.
- (1^2) From grades 7 to 9 in educational programmes for ethnic minorities, the acquisition of learning content in the official language shall be ensured in the amount of not less than 80 per cent of the total lesson load in an academic year, including foreign languages.
- (2) Educational programmes for ethnic minorities shall additionally include the content necessary for the acquisition of the relevant ethnic culture and integration of ethnic minorities in Latvia.

7. Supplement Chapter V with Section 47.³ in the following wording:

Chapter V. Guidelines for State Pre-school Education, State Education Standards and Educational Programmes

Section 47. Interest-related Educational Programmes

- (1) Interest-related education shall be voluntary, and education corresponding to a particular level of education shall not be required for its commencement.
- (2) Educational institutions are entitled to implement interest-related educational programmes without the receipt of a licence.
- (3) After receipt of the relevant licence from a local government, other legal persons and natural persons not registered in the Register of Educational Institutions are also entitled to implement interest-related educational programmes.

 (..)
- "Section 47.3. Minority languages and cultural history interest-related education programmes The municipality provides an opportunity for minority educatees, who study the pre-school education programme or basic education programme in the general education institutions located in its administrative territory, also to learn the content of minority education free of charge in educational programmes of minority languages and cultural history interest-related education programmes. In order to provide minority educatees with the opportunity to learn these

programmes, the municipality can delegate the implementation of such programme to a private person."

8. Section 48:

supplement Section with Paragraph 5¹ in the following wording:

Section 48. Right to Work as a Teacher

- (5) A person who is loyal to the Republic of Latvia and its Constitution, inter alia, does not violate the prohibition of discrimination and differential treatment towards a person, has the right to work as a teacher.
- " (5^1) A person who knows and uses the official language to the extent necessary for the performance of professional and official duties specified in the regulatory enactments has the right to work as a teacher. This provision does not apply to what is mentioned in Paragraphs 2 and 3^1 of Section 9 of this Law."

Supplement Section with Paragraphs 7 and 8 in the following wording:

- "(7) If the State Language Centre has established that the knowledge of the official language of the teacher does not correspond to the level of official language proficiency determined by the Cabinet of Ministers, which is necessary for the performance of his professional and official duties, an entry is immediately made into the Register of Teachers. The head of the educational institution shall ensure that the relevant teacher is suspended from the performance of his duties until the day he passes the official language proficiency exam to the extent necessary for the performance of professional and official duties. If, within three months, the teacher has not passed the examination on knowledge of the official language to the extent necessary for the performance of professional and official duties, the employment legal relationship with him shall be terminated. An appeal against a decision taken by the State Language Centre shall not suspend its operation.
- (8) The entry in the Register of Teachers referred to in Paragraph 7 of this Section is immediately deleted if the finding of the State Language Center regarding an insufficient level of proficiency in the official language is canceled or information on the passing of the official language proficiency exam of the relevant teacher is updated in the State Examinations Information System to the extent necessary for the performance of professional and official duties.

9. Express Section 50, Paragraph 1, Clause 3 in the following wording:

Section 50. Restrictions on Working as a Teacher

- (1) The following persons may not work as teachers:
- 1) a person who has been punished for committing an intentional criminal offence (regardless of the criminal record having been set aside or extinguished), except for when after setting aside or extinguishing the criminal record the State Education Quality Service has evaluated whether it does not harm the interests of educatees and has permitted that such person works as a teacher. The Cabinet shall determine the procedures by which the head of an educational institution shall ascertain whether the person has restrictions to work as a teacher, and also the procedures for the evaluation whether the permission for such person to work as a teacher will not harm the interests of educatees;
- 2) a person whose capacity to act is limited in accordance with procedures laid down in laws and regulations;

- 3) in State or local government educational institutions, and also secondary education institution of State higher education institutions—a person who does not have a document issued in accordance with the procedures stipulated by the Cabinet that certifies the proficiency in the official language at the highest level, except for the academic personnel of higher education institutions—citizens of other countries and stateless persons who are participating in the implementation of specific educational programmes on the basis of an international agreement;
- "3) a person who, following the finding of the State Language Center about the non-compliance of his official language knowledge with the level of official language proficiency determined by the Cabinet of Ministers, which is necessary for the performance of professional and official duties, has not passed the official language proficiency exam. This provision does not apply to Paragraphs 2 and 3.1 of Section 9 of this Law;".

10. Supplement Section 55 with Clause 2. in the following wording: Section 55. Rights of an Educatee

An educatee has the following rights:

- 1) to the acquisition of pre-school education, basic education, and secondary education paid by the State or local government;
- 2) to freely express and defend his or her views and opinions during the educational and upbringing process, not insulting the dignity and honour of other persons;

"2¹) receive individualised and personalised support for learning the official language in pre-school education and basic education, if necessary;".

11. Section 59:

in the Paragraph 1, replace the words "are implementing educational programmes for ethnic minorities in which the number of minority educatees does not exceed six per cent of the total number of educatees who are acquiring educational programmes for ethnic minorities" with the words "are implementing educational content for ethnic minorities";

supplement Section with Paragraph 1.1 in the following wording:

Section 59. Sources of Financing of the Education System

(1) State educational institutions shall be financed from the State budget in accordance with the annual State budget law. Local government educational institutions shall be financed from local government budgets. Secondary education institutions of State higher education institutions shall be financed from the budgets of higher education institutions. The State shall participate in the financing of local government educational institutions and secondary education institutions of the State higher education institutions in the cases provided for in this Law. In order to promote the acquisition, development, and preservation of the minority ethnic culture and the integration of minorities in Latvia, the State may participate in additional financing of work remuneration for the teachers employed at educational institutions which, on the basis of bilateral and multilateral international agreements of the Republic of Latvia, are implementing educational programmes for ethnic minorities in which the number of minority educatees does not exceed six per cent of the total number of educatees who are acquiring educational programmes for ethnic minorities. content for ethnic minorities.

"(1¹) The state participates in the financing of the costs of the implementation of the minority language and cultural history interest-related education programmes (teachers' remuneration, mandatory state social insurance contributions, purchase of teaching materials) in accordance with the procedures and to the extent determined by the Cabinet of Ministers."

Transitional Provisions

12. Supplement the Transitional Provisions with Paragraphs 101, 102, 103, 104, 105, 106, 107 and 108 in the following wording:

- 101. The information referred to in Section 35¹ Paragraph 1 Clause 4 of this Law regarding Olympiads of study subjects shall be entered into the State Examination Information System starting from September 1, 2023.
- 102. Amendments providing for the exclusion of Section 41 of this Law shall enter into force:
- 1) September 1, 2023 regarding the implementation of the pre-school education programme and the general education basic education programme in grades 1, 4 and 7;
- 2) September 1, 2024 for the implementation of the general education basic education programme in the grades 2, 5 and 8;
- 3) September 1, 2025 regarding the implementation of the general education basic education programme in the grades 3, 6 and 9.
- 103. The opportunity to learn the minority languages and cultural history interest-related education programmes specified in Section 47³ of this Law is provided by:
- 1) preschool education programmes and general education basic education programmes for 1st, 4th and 7th grade educatees as of September 1, 2023;
- 2) for educatees of the 2nd, 5th and 8th grades of the basic education programmes of general education as of September 1, 2024;
- 3) for educatees of the 3rd, 6th and 9th grades of the general education basic education programmes as of September 1, 2025.
- 104. The Cabinet shall, by December 31, 2022, amend the Cabinet Regulations No. 716 "Regulations regarding the State Pre-school Education Guidelines and Samples of Pre-school Education Programmes" of November 21, 2018 and Cabinet Regulation No. 747 "Regulations regarding State Basic Education Standards and Samples of Basic Education Programmes" of November 27, 2018 in accordance with the amendments introduced to Section 9, Paragraph 2, Clause 2; Section 38, Paragraph 2, Clause 1 and Section 41 of this Law.
- 105. The Cabinet shall, by December 31, 2022, issue the regulations referring to an Section 14, Paragraphs 47 and 48 of this Law.
- 106. Educational institutions shall ensure compliance of pre-school education and basic education programmes with the state pre-school education guidelines and the state basic education standard, if necessary, by licensing new educational programmes not later than by August 31, 2025.

107. The Cabinet shall, by December 31, 2022, amend the Cabinet Regulations No. 276 "Regulations of the State Education Information System" of June 25, 2019 in accordance with the amendments in Section 30 of this Law regarding its supplementation with Paragraphs 7 and 8 and Section 48 regarding its supplementation with Paragraphs 7 and 8.

108. The entries mentioned in Section 30 Paragraphs 7 and 8 and Section 48 Paragraphs 7 and 8 of this Law shall be made in the Register of Teachers from January 1, 2023. By December 31, 2022, the State Language Center shall immediately inform the employer of the head of the educational institution or the head of the educational institution, respectively, of the finding referred to in Section 30 Paragraph 7 and Section 48 Paragraph 7 of this Law."

II. Comments on the content of the amendments

The amendments provide for the following tasks:

- (1) exclusion from the law of references to educational programs for national minorities (Sections 1,5,6);
- (2) inclusion in the law of guarantees for minorities to learn their native language in interest-related [hobby] education program programs (Sections 2,7);
- (3) simplification of the procedure of dismissal of the heads of educational institutions and teachers on the basis of insufficient knowledge of the state language (Sections 3,8,9);
- (4) supplementing the rights of an educatee with the right to receive individualised and personalised support for learning the official language in pre-school education and basic education (Section 10);
- (5) funding for minority language and cultural history interest-related education programs (Sections 2,11);
- (6) establishment of a shot transitional period to a new educational system (Section 12)

1. Exclusion from the law of references to educational programs for national minorities.

This exclusion means that students belonging to the national minorities and to the state nation will study in the same curriculum entirely in Latvian. For example, the Latvian language will be studied by representatives of national minorities as a native language, starting from preschool institutions.

2. Inclusion in the law of guarantees for minorities to learn their native language in interest-related [hobby] education programs.

According to Educational law (Article 1, Clause 3) interest-related education – implementation of the individual educational needs and desires of a person regardless of age and previously acquired education.

Providing free education for representatives of national minorities in such interest-related education programmes is entrusted to the municipalities.

3. Simplification of the procedure of dismissal of the teachers on the basis of insufficient knowledge of the state language.

Such qualification requirement for a teacher as knowledge of the state language for the highest category was introduced alongside with the entry into force of the "Education law" (1999). Previously, compliance with the requirement when hiring was confirmed by the relevant qualification document. The State Language Centre carried out permanent inspections of teachers of those schools that implemented programmes for national minorities and fined them for non-compliance with the requirements. In 2018, the State Language Centre set a fine on 143 or 10% of teachers in national minority schools²².

Previously, the imposition of a fine could be appealed in court, and the very fact of punishment was not a basis for suspending a teacher from work.

In the new regulation, a negative opinion of the State Language Centre leads to the fine as well as to the immediate suspension of the teacher from work. The teacher is given a three-month period to pass a full-fledged language proficiency exam, and if he/she fails, dismissal without compensation follows. This also applies to teachers of the Russian language and to kindergarten teachers. Appealing the decisions of the State Language Centre in court does not suspend this process.

In contrast to the process of replacing the educational programmes of national minorities with interest-related classes, the conditions for a purge of teachers do not have a transitional period; they entered into force immediately along with the law.

4. Rights to receive individualised and personalised support for learning the official language

During the discussion of the bill in Parliament, as compensation for refusal of proposal to grant the right for educates belonging to ethnic minorities to receive additional explanations of educational material in their native language directly in the classroom or in kindergarten, the proposal concerning the right to receive individualized and personalized support for learning the official language has been adopted by the minimum number of votes. At this moment, in conditions of a catastrophic shortage of teachers, including teachers of the Latvian language, this norm cannot be implemented in practice.

5. Funding of minority language and cultural history interest-related education programmes.

In general, the financing of teachers' salaries is the responsibility of the State. The bill introduced by the Ministry of Education and Science to the Government in April 2022 provided for the distribution of funding for programmes for educatees belonging to national minorities between the State and municipalities in the proportion of 50:50.

The bill introduced by the government to Parliament no longer contained the provision of State's obligations to finance these programmes. During the discussion of the bill in Parliament, the State was charged with the obligation to participate in the financing of minority language and cultural history interest-related education programmes in the manner that will be established by the rules of the Cabinet of Ministers until 31.12.2022.

Freedom of assembly. Memorials, Meetings and processions

I. Memorials

1. On June 16, 2022, the law «On the prohibition of exhibiting objects glorifying the Soviet and Nazi regimes and their dismantling on the territory of the Republic of Latvia» was adopted by Parliament and on June 22 it came into force¹ (hereinafter - the Demolition Law). The municipalities in which territory they are located are ordered to dismantle the monuments the title of the law refers before November 15, 2022 (Article 5.5).

Article 4 of the Demolition law names the monument to the Liberators of Riga² by name, and also instructs the government to submit a list of objects subject to mandatory dismantling and the right for municipalities to dismantle other objects as well.

On July 14, 2022, the government regulations No. 448 "List of objects glorifying the Soviet and Nazi regimes to be dismantled on the territory of the Republic of Latvia" were adopted, containing a list of 69 objects to be dismantled.

The list, despite the name of the above-mentioned regulations, includes only monuments of the Soviet era, mainly monuments to the soldiers of the anti-Hitler coalition.

- 2. In the three largest cities of Latvia, which are Riga, Daugavpils and Liepaja, the following monuments are subject to dismantling.
- **3.** In Riga, in addition to the monument to the Liberators, objects numbered 21, 25 and 26 are subject to demolition:
- [21] Obelisk of the 374th Rifle Division, which began the liberation of Riga from Nazi invaders⁴;
- [26] Memorial sign a stone at the site of the offensive of the Red Army on the banks of Kishozero⁵;
- [25] Monument to the soldiers of the Red Army in Rumbula⁶.

The Riga City Council adopted the following decisions on the demolition of monuments:

- (1) May 13 regarding the monument to the Liberators of Riga;
- (2) July 20 regarding the Obelisk and the Memorial Sign;
- (3) August 24 regarding the Monument to the soldiers of the Red Army in Rumbula.

The dismantling of the monument to the Liberators began on August 24⁷ and is almost completed at the moment, the rest of the decisions have not yet been carried out.

4. The lists under numbers 59 and 60 include two monuments from Daugavpils: obelisk and memorial stele in Glory square⁸, as well as an obelisk dedicated to the 360th Infantry Division, which fought for the liberation of Daugavpils from the Nazis⁹.

The Daugavpils City Council strongly opposes their demolition (see paragraph 2.3 below). The government is threatening to dissolve the council.

- **5.** The list under numbers 8, 9 and 10 contains three monuments located on the territory of Liepaja:
- [8] Monument to the defenders of Liepaja¹⁰;
- [9] Memorial stone with a memorial plaque to General Nikolai Dedayev¹¹;
- [10] Memorial wall of the Middle Fort dedicated to the defenders of Liepaja¹².

The Liepaja City Council provides citizens and even its own opposition deputies with minimal information on plans for the dismantling of the above-mentioned monuments.

It is only known that a certain working group has been created, which is developing a procedure for the demolition of these monuments and "has information about 20 other objects in Liepaja related to the events of the Second World War." ¹³.

The monument to General Dedayev was demolished on August 24 without any prior public notice 14.

6. Monuments dedicated to the victory in World War II are an essential element of the cultural identity of the people of Russia¹⁵ and the Russian linguistic minority of Latvia.

A full-scale public opinion poll in June 2022 showed that the idea to demolish the monument to Soviet soldiers in Riga was supported by 49% of respondents, and not supported by 35%. Among those whose native language is Russian, only 9% supported the dismantling of the monument, 55% definitely did not support it, and rather 21% of the respondents did not support it.

May 9, Victory Day is celebrated by tens of thousands of people all over Latvia near the monuments to be dismantled ¹⁷ ¹⁸ ¹⁹ ²⁰.

Therefore, deputies of factions representing national minorities voted in the parliament against the Demolition Law (Social Democratic Party Harmony, hereinafter - Harmony), and in the Riga City Council (Harmony and the Latvian Russian Union, hereinafter - LRU) - against all three decisions mentioned above in clause 2.2.1.

The LRU party collected 10,000 signatures and submitted to the Committee on Petitions of the European Parliament²¹ against the demolition of monuments to the heroes and victims of World War II and the Russophobia campaign in Latvia²². In December 2022, a decision was made on the admissibility of the petition, but it has not yet been considered.

7. Appeal to the courts against decisions on the demolition of monuments is blocked by Article 6.8 of the Demolition Law: any challenge or appeal against the decision to dismantle the object does not stop its operation. In addition, courts of general jurisdiction, including administrative ones, do not initiate cases against acts of general validity.

A group of 5 persons appealed against the decision to demolish the monument to the Liberators of Riga in the Constitutional Court, however, on August 23, the Collegium of the Court refused to initiate a case. A communication submitted by this group on 24 August to the UN Human Rights Committee under the Optional Protocol was more successful: On August 26, the Committee registered the communication (no. 4203/2022) and sent a letter to the Latvian Ministry of Foreign Affairs on the adoption of interim measures, in which, in particular, it requested to refrain from dismantling the monuments which are the object of this communication and to ensure the conservation of the pieces of the monuments which have already been dismantled while the communication is under consideration by the Committee. The Ministry of Foreign Affairs noted

that the Committee's letter arrived too late²³, but the dismantling of the monument continued after the Latvian authorities were acquainted with the Committee's decision²⁴.

On June 30, 2022, the Daugavpils City Council, in accordance with Article 19 of the Law on the Constitutional Court²⁵ and Article 49 of the Law on Local Governments²⁶, decided to challenge the Demolition Law in the Constitutional Court²⁷. However, on September 14, the Collegium of the Court also refused to initiate a case²⁸. When the municipality re-applied, the case was initiated, but has not yet been considered.

In both cases, the Collegium stated that the Constitutional Court has no right and will not take interim measures to suspend the Demolition Law, i.e. all internal protection measures are recognized as obviously ineffective. Accordingly, between September 3 and 8, two deputies of the Riga City Council (including the author of this report), the vice-mayor of Daugavpils and an activist of the search teams of dead soldiers from Liepaja also submitted separate communications to the Committee regarding their surviving city monuments, but the Committee has not yet responded.

Later, between September 30 and October 26, 2022, the UN Human Rights Committee adopted a decision on interim measures in relation to all the monuments described above in Riga, Daugavpils, Liepaja and Rēzekne (cases No. 4226, 4234, 4235, 4236/2022). All these decisions were ignored and all the monuments were demolished.

II Meetings and processions

8. In 2022, the freedom of assembly, in which representatives of national minorities could take part, is also significantly limited.

Amendments of the same type were adopted in the Law on the Safety of Public Entertainment and Festivity Events (Bill No 1379/Lp13, 04.04.2022) and Law On Meetings, Processions, and Pickets (Bill No 1418/Lp13, 21.04.2022), prohibiting events closer than 200 meters from any monument glorifying the victory and memory of the Soviet army or its soldiers in the territory of Latvia. By special law On the establishment of a day of remembrance for the victims in Ukraine (Bill No 1419/Lp13, 07.04.2022).

The monument to the Liberators of Riga and Latvia from the Nazi invaders, around which tens of thousands of people gather on May 9, was surrounded by a fence by the decision of the Riga City Council and the issue of its demolition is being actively discussed²⁹.

On the eve of May 9, 2022, the monument was fenced off, and the authorities published calls for him not to come³⁰.

On May 9, access to the monument was completely blocked, tens of thousands of people put flowers on special tables, from where municipal workers carried them to the foot of the monument³¹.

On May 10 at 5.00 the flowers were removed from the monument using a tractor. Outraged residents of Riga on May 10 again strewn the monument with flowers, especially since a partial approach to the monument was restored³². By evening, arrests began to take place at the monument, and at about 10.30 pm, people were pushed back from the monument by police special forces³³.

As a result, a vast area around the monument was fenced until August 31, 2022³⁴.

9. In Latvia, after the events of May 9, only three street actions were announced in defense of the monuments to the fighters of the anti-Hitler coalition to be demolished: on May 13, May 28 and August 22. All these actions were applied by deputies of the Riga City Council from the LRU faction (the last two - by the co-chairman of the LRU party and, since July, the leader of the electoral list of this party, Miroslavs Mitrofanovs). In all three cases, the Riga City Council prohibited these actions on the proposal of the State Security Service³⁵. The prohibitions were challenged in court (cases Nos. A420202922, A420209922, A420247322³⁶), all three cases were lost, the judgment of the court of first instance was appealed to the Senate of the Supreme Court. In December-January, the Supreme Court initiated relevant proceedings, which have not yet been completed.

10. On May 10, deputies of the Riga City Council from the party Latvian Russian Union (LRU)³⁷ and Social Democratic Party Harmony (Harmony)³⁸ applied to hold a meeting on the Town Hall Square at the entrance to the building of the Riga City Council on May 13 at 15.00. The goals of the meeting indicated in the application are to condemn the actions of the Riga authorities near the monument, as well as to discuss the plans of the parliamentary majority announced by the ruling coalition on May 9³⁹: to legalize the demolition of monuments and eliminate education in Russian. The authorities exerted public pressure on the Riga City Council in order to force it to ban the meeting⁴⁰. On May 12, in the afternoon, at a conference with the Executive Director of Riga with the participation of the applicants, it was decided to ban the meeting. The decision on the ban, issued at 17:00 on May 12, was appealed in court at 22:00. Starting from 17.00, the LRU party began to disseminate information on social networks calling not to come to the banned meeting. The trial took place on May 13 in the "zoom" mode from 12.00 to the announcement of a negative short judgment at 14.40.⁴¹. The full judgment will be published on June 3⁴² and can be appealed to the Senate of the Supreme Court.

The decision to convene an extraordinary session of the Riga City Council at 14.00 on May 13 with the only agenda item - the demolition of the monument - was announced to the opposition deputies three hours before it began. The session was held in the "zoom" mode, and the City Council employees were ordered to leave the city hall building before 15.00.

At the time of the planned start of the meeting (15.00), deputies of the LRU faction (they were together with several supporters inside the Council building) went to the Town Hall Square in order to warn people about the prohibition of the meeting ⁴³. Access to the Town Hall Square was blocked by barriers and police detachments. The Council deputies were assisted by MEP Tatjana Ždanoka and two another LRU activists. The last three people were holding banners with the inscription "The meeting is prohibited", were detained by the police, taken to the police station and administrative proceedings were initiated against them⁴⁴.

11. An application for the march on May 28 with an estimated number of participants of 100 people was submitted by Miroslavs Motrofanovs on May 16.

A much larger event, announced for May 20 - the procession from the Monument of Freedom to the Monument of Liberators of Riga and Latvia from the Nazi invaders - the Riga City Council was not going to interfere⁴⁵. It was supposed to block traffic on the bridge across the Daugava River on Friday during a rush hour, while the residents of Riga leave for their summer cottages⁴⁶. Apparently, the mayors of Riga like the ideology of the procession: destruction of all monuments of the Soviet era, deportation from Latvia of all those who do not agree with this, as well as the introduction of deprivation of citizenship for these persons, lustration and restrictions on the right to participate in elections⁴⁷. About 5,000 people participated in the procession, according to police⁴⁸.

Miroslav Mitrofanov's application for a procession along the same route, but in the exact opposite direction and with exactly the opposite slogans, scheduled for a day off, crossing the bridge along the sidewalks, was nevertheless rejected.

The court confirmed the prohibition on the march, mainly arguing that the LRU is "the wrong party with the wrong ideology", moreover, responsible for all violations of public order that occurred between May 9 and 13.

Indeed, for the actions of the party and its individual members during this period, the police opened several trials on administrative offenses. However, at the time of sentencing in the procession case, none of these cases had been completed. To date, almost all of these cases have been won by LRU lawyers when appealed within the police, one - for a published May 10 call on the Tik-Tok social network to re-lay flowers at the monument to the Liberators of Riga instead of those demolished by a bulldozer - is pending in court⁴⁹.

As for "the wrong party with the wrong ideology", the electoral list of the LRU on July 29 was registered without comment by the Central Election Commission, so voters will decide on the "wrongness" of the party.

A fragment of the election program of the LRU regarding monuments⁵⁰: The ruling parties are trying to shift the blame to the Russian-speaking population of Latvia. The interests of this part of the nation are undermined: a complete ban on the use of the Russian language in schools, **the demolition of monuments dedicated to the liberation of Latvia from Nazism**, the exclusion of Russian television channels, the spread of a Russophobia campaign in the mass media. Deputies

of the Latvian Russian Union: (..) will stop the demolition campaign of monuments dedicated to the victims and soldiers of the Second World War ..

- 12. On August 16, the leader of the electoral list of the RSL, Miroslavs Mitrofanovs, filed an application for a meeting on August 22 within sight of the monument to the Liberators of Riga. The reason for filing the application was the press conference of the Mayor of Riga, where he accidentally partially disclosed the date of the beginning of the demolition of the monument (August 24), which was carefully hidden from the public and opposition deputies. The mayor's office prohibited the event only on August 22, 7 hours before the planned start of the meeting. The court considered the complaint against the decision of the mayor's office only on August 25 and dismissed it with motives similar to those set out above.
- **13.** It should be noted that the requests of the LRU for actions not related to the protection of monuments did not arouse objections from the Riga City Council. Also, the authors of the report are not aware of cases of obstruction of street events of other political forces and other restrictions on street election campaigning.
